Trailer must have sufficient lighting. All signs must be professional quality (hand written signs are not permitted.) Advertising outside of the contracted space is prohibited. Tents are not accepted unless approved by the Colorado State Fair.

Each concessionaire is required to have a **Certificate of Insurance** showing a Comprehensive General Liability policy, Standard Colorado **Worker's Compensation and Automobile Liability** on the vehicle that pulls the concession trailer.

***The requirements must be valid during the Event dates and submitted with the signed contract. You will not be allowed to set up without these documents!***

**All concessionaires must use and provide their own cash registers.**

**CONCESSION RATES** Food concessionaires pay 25% of gross sales after taxes, against a guarantee. There is a \$50.00 space fee, which includes utilities (electrical, water, sewer), trash removal and grounds clean up.

**PEPSI COLA®** is the official soft drink, bottled water, and cup sponsor of the Colorado State Fair. ***No other soft drink, bottled water, or cups may be sold or advertised.***
