PHOTOS of your concession trailer as it is operated ARE REQUIRED with application. Trailers must be skirted on all sides including the hitch. Storage areas must be completely enclosed. Trailer must have sufficient lighting. All signs must be professional quality (hand written signs are not permitted.) Advertising outside of the contracted space is prohibited. Tents are not accepted unless approved by the Colorado State Fair.

Each concessionaire is required to have a **Certificate of Insurance** showing a Comprehensive General Liability policy, Standard Colorado **Worker's Compensation and Automobile Liability** on the vehicle that pulls the concession trailer.

The requirements must be valid during the Event dates and submitted with the signed contract. You will not be allowed to set up without these documents!

All concessionaires must use and provide their own cash registers.

Terms of the concessionaire contract, should you be offered space, requires a **DEPOSIT OF ONE-HALF** of the total cost returned with signed contract. Contracts offered after July 30, 2010 will require **FULL PAYMENT** with signed contract.

CONCESSION RATES Food concessionaires pay **25% of gross sales after taxes, against a guarantee.** There is a **\$50.00 space fee, which includes utilities (electrical, water, sewer), trash removal and grounds clean up.**
